







The Census determines how federal funding gets allocated for the next 10 years. That means funding for education, health care, housing, emergency services, infrastructure, and more is at stake. If our residents aren't properly counted, or members of our community are missed during the counting period, we might not receive the resources we need to support our diverse and growing population.

While you can complete the Census over the phone or by mail, for the first time ever you can also respond online. Use the web site <u>my2020census.gov</u>, using the census ID you received in the mail. Call toll-free 1-844-330-2020 if you have any questions or problems.

There is **no cost** to fill out the Census, and it will **not** ask for your social security number or immigration status. Your personal information is kept confidential and will **not** be shared with law enforcement. Your response is required by law.

It is critical that every resident and household in our country is properly counted, and the Census is a big part of ensuring necessary resources are allocated fairly.

If you haven't done it already, we hope you'll take the 10 minutes to complete the census-- for you, your neighbors, our schools, our roads and so much more.

The Community Foundation has cancelled all room usage meeting until June 30th, therefore our next meeting will probably take place in September. As April is our Annual General Meeting, where we hold elections and vote on the proposed budget and philanthropy plan, these are items that will have to be deferred until we can safely meet again, hopefully in September. The branch will give the \$2400 from our endowment funds, as voted on last April.

On April 6 you should have received an email from AAUW Florida titled Annual Meeting Special Edition FloriVision. If you didn't receive this email, check your spam folder, and if you still can't find it, it probably means that your email address listed on the National Member database is incorrect. Our branch records are different from the National records, so please go to www.aauw.org , log in with your membership number (which is listed in our Yearbook under your email address) and password, and if the two emails aren't the same, you can change the one on the national list. We cannot change it for you because we don't have your password. And then let me know so I can forward the information to you. If your email is incorrect, you also are missing the opportunity to vote in both the AAUW Florida and AAUW National elections taking place now.

We will be retrieving mail infrequently as long as public health officials are encouraging us to stay at home or to avoid highly trafficked public places. **IF POSSIBLE, PLEASE RENEW ONLINE.**
